When parents was asked, do you agree with the actions the school will take to provide parents of participating children the information about Title I Programs, curriculum, academic assessments, regular meetings, etc.? 88.5% replied yes and 0% replied no. The parents agreed that the school offering a parent math series this school year will be good.
- 5. When parents were asked, do you agree with the following actions the school will take to jointly develop with parents give parents to give input and it will be an ongoing opportunity for parents. Of participating children a school-parent compact? 96.0% replied yes and 0% no.
- 6. - 6. Involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
- 7. Provide necessary literacy training for parents from Title I, Part A funds if the school has exhausted all other reasonably available sources of funding for that training.
